NATIONAL NOTICE TO LESSEES AND OPERATORS OF FEDERAL OIL, GAS, AND
SULPHUR LEASES ON THE OUTER CONTINENTAL SHELF

Authority

In accordance with 30 CFR 250.1920 and 250.1929, you must submit to BSEE your audit plans, reports and corrective action plans (CAPs) associated with your Safety and Environmental Management System (SEMS) programs, as well as the Form BSEE-0131 (OCS Performance Measures Data).

Purpose

This Notice to Lessees and Operators (NTL) updates and supersedes NTL 2018-N02. The purpose of this NTL is to provide:

- Notification of the availability of a method for the electronic submission of SEMS audit plans, reports and corrective plans, and for the management of communications about the submissions (SEMS Portal);
- Directions to the SEMS Portal website, where you can find instructions regarding 1) the submission of audit plans, audit reports, and corrective action plans, and 2) communications with BSEE SEMS regarding these submissions;
- Notification of the availability of a method for the electronic submission of Form BSEE-0131, Performance Measures Data (Performance Measures Data Portal);
- Directions to the BSEE OCS Performance Measures website, where you can obtain Form BSEE-0131, and instructions regarding filling out the form, submitting it, as well as information about the OCS Performance Measures Program;
- Clarification about reporting hours worked by company and contractor personnel to complete Form BSEE-0131; and
- Contact information for persons who can provide assistance regarding the submission of SEMS documents.

Electronic Collection Now Available

In an effort to make SEMS document submission, collection, and analysis more efficient, BSEE has developed two software applications that accept electronic versions of the following SEMS-related documents:

- **SEMS Portal:** A software application that accepts electronic versions of audit plans, audit reports, audit corrective action plans and updates.
- **Performance Measures Data Portal:** A software application that accepts electronic versions of Form BSEE-0131.

These applications reside in BSEE's Technical Information Management System (TIMS) Web, and can be found here: <https://timsweb.bsee.gov/>. BSEE TIMS is the Bureau's core mission application for planning, permitting, and reporting functions; it provides the tools to manage the wide array of data and information needed to accomplish the Bureau's day-to-day mission requirements effectively. TIMS Web is the industry's portal for electronic submission of documents and data to BSEE.

SEMS Portal

The new SEMS Portal efficiently consolidates document submission mechanics and necessary record-keeping for SEMS audit plans, audit reports, initial CAPs, quarterly CAP updates, and final CAPs. Upon logging in, a dashboard appears that identifies pending action items, requests for information, and historical submissions. The dashboard fields and columns are searchable and customizable to view only desired data. In addition to managing submissions, BSEE intends to use the SEMS Portal to communicate with operators about their SEMS submissions (e.g., requesting revisions to audit plans and CAPs). BSEE will continue to accept PDF and paper versions of SEMS audit plans, audit reports, initial CAPs, quarterly CAP updates, and final CAPs if an operator prefers not to use the SEMS Portal.

Performance Measures Data Portal

The Performance Measures Data Portal enables the user to enter data into an online Form BSEE-0131, save and submit the data, and keep track of previous submissions. The data collected online are the same data that are collected with the PDF and paper versions of the form. BSEE will continue to accept PDF and paper versions of Form BSEE-0131 if an operator prefers not to use the electronic form.

- Historical OCS Performance Measures data.

You must submit your performance measures data using the current version of Form BSEE-0131, which is available in the Performance Measures Data Portal and posted on the BSEE OCS Performance Measures website listed above. The form collects data from the prior calendar year.

Clarification on How to Report Hours Worked on Form BSEE-0131

Sections E and F on Form BSEE-0131 are for reporting hours worked by company and contractor personnel, respectively. This value is the number of **actual hours worked** during the calendar year on the OCS by **production, drilling, and construction** operations employees assigned to an operator's OCS locations. Transportation hours worked offshore (pilot hours, employee being transferred from base to facility and back, transportation of materials/equipment/supplies, etc.) should include all time worked

regardless of location, but should be allocated among multiple operators (if the services are shared), and distributed among the categories identified in boldface above. Do not include hours for which the employee is off-work or sleeping. Therefore, record hours on a 24-hour basis only in the unusual event that an employee works through a full day.
