Greetings ANCSA Corporation Leader:

On behalf of the Bureau of Safety and Environmental Enforcement (BSEE), I would like to provide information and invite you or your designee to participate in government-to-corporation consultation on a proposed rulemaking, *Revisions to Subpart J – Pipelines and Pipeline Rights-of-Way* (Regulatory Identification Number 1014-AA45).

Background

BSEE promotes safety, protects the environment, and conserves resources offshore through vigorous regulatory oversight and enforcement under the Outer Continental Shelf Lands Act (OCSLA), among other laws. OCSLA authorizes BSEE to regulate energy- and minerals-related activities on the U.S. Outer Continental Shelf (OCS), which is seaward of states' jurisdiction off the West Coast and Hawai'i in the Pacific Ocean; off Alaska in the Beaufort and Chukchi Seas, the Bering Sea, and Cook Inlet; in the Gulf of America; and off the East Coast in the Atlantic Ocean.

BSEE is committed to partnering on a nation-to-corporation basis with Alaska Native Claims Settlement Act (ANCSA) Corporations regarding BSEE actions on the OCS that could have ANCSA Corporation implications.

BSEE regulates oil and gas pipelines on the OCS to ensure operators conduct their activities safely and in an environmentally sound manner. BSEE's pipeline regulations are located in 30 CFR 250 Subpart J.¹ Regulatory activities under Subpart J range from permitting the design and installation to decommissioning of all pipelines on the U.S. OCS. BSEE plans to prepare a rule that would update 30 CFR 250 Subpart J to improve pipeline safety, environmental protection, and equipment reliability.

In May 2023, BSEE sent a letter notifying ANCSA Corporations of the initial development of proposed rulemaking 1014-AA45, *Revisions to Subpart J – Pipelines and Pipeline Rights-of-Way*, and inviting government-to-corporation consultation.

In March 2024, BSEE sent a letter notifying ANCSA Corporations of the regulatory agenda for rulemakings that BSEE planned to pursue over the next few years. The regulatory agenda included continued proposed rulemaking 1014-AA45, *Pipelines and Pipeline Rights-of-Way Rule*.²

Summary of the Proposed Rulemaking

BSEE's regulations in 30 CFR Part 250 were published in 1988 and have not been significantly revised. This proposed rule would substantially revise BSEE's pipelines and pipeline rights-of-way regulations on the OCS. It would incorporate content from current BSEE policies, guidance

documents, conditions of approval, and updated industry standards into the regulations. It would incorporate content from current BSEE policies, guidance documents, conditions of approval, and updated industry standards into the regulations, resulting in up-to-date pipeline regulations that reflect current industry practices and BSEE policies.

Key updates for the proposed rule include, but are not limited to:

- Address recommendations in a March 2021 Government Accountability Office report, *Offshore Oil and Gas: Updated Regulations Needed to Improve Pipeline Oversight and Decommissioning* (GAO-21-293).³
- Pipeline and riser design and installation.
- Pipeline testing.
- Safety equipment and leak detection.
- Pipeline operations and maintenance.
- Pipeline modifications and repairs.
- Pipeline decommissioning.
- Pipeline right-of-way grants.
- Umbilicals.

Tentative Schedule and Consultation Invitation

The tentative schedule for this proposed rulemaking includes publishing a Notice of Proposed Rulemaking in the Federal Register by January 2026. We will provide the Notice of Proposed Rulemaking once it is available.

In accordance with the Department of the Interior's Policy on Consultation with Alaska Native Claims Settlement Act Corporations,⁴ BSEE is seeking your input on proposed rulemaking 1014-AA45 *Revisions to Subpart J – Pipelines and Pipeline Rights-of-Way*. Input from ANCSA Corporations is important to shaping effective regulations and BSEE's process for developing this proposed rule.
