Inspect each diesel engine or engine-driven equipment to verify that it is equipped with a spark arrester on the exhaust piping.

1. Includes all contract and rental equipment whether temporarily or permanently installed.
2. Straight exhaust is not acceptable.

If Noncompliance Exists:

Issue a component shut-in (C) INC for a diesel engine or engine-driven equipment when the exhaust piping is not equipped with a spark arrester.

Inspection INC Count:

Issue one INC for each engine inspected.
