Conditions of Approval 1)All operations must be conducted in accordance with the Outer Continental Shelf Lands Act (OCSLA), lease terms and stipulations, 30 CFR Part 250 regulations, applicable Notices to Lessees and Operators (NTLs), the approved (revised) Application for Permit to Modify (APM/RPM), and any written instructions or orders issued by the District Manager. 2)A copy of this permit, including all attachments, must be kept on location and made available to inspectors upon request throughout the duration of the permitted operation. 3)Operators must maintain current Oil Spill Financial Responsibility (OSFR) coverage for the lease. If coverage is set to expire during operations, a revised RPM must be submitted to BSEE prior to the expiration date. 4) If well pressures exceed the permitted Maximum Anticipated Surface Pressure (MASP) or Shut-In Tubing Pressure (SITP), the well control equipment must be tested to the new observed pressure plus 500 psi. Notify the appropriate District immediately and submit a revised RPM documenting the change. Wireline lubricators must be tested to equal or exceed the new pressure if wireline is used. 5)Notify the Permitting Section at least 24 hours in advance of: Commencing approved operations. Conducting plug testing or tagging. Operations must not proceed until an inspector is present or the Section Chief (or designee) waives the witnessing requirement. Any casing or annuli that fail a pressure or bubble test must be reported and remediated in accordance with regulatory requirements. 6)Well Activity Reports (WAR) are due no later than noon every Wednesday.
