Conditions of Approval: 1)All operations must be conducted in accordance with the OCS Lands Act (OCSLA), the lease terms and stipulations, the regulations of 30 CFR Part 250, Notices to Lessees and Operators (NTLs), the approved (revised) Application for Permit to Modify (APM/RPM), and any written instructions or orders of the District Manager. 2)A copy of this permit (including all attachments) must be kept on location and made available to inspectors upon request during the permitted operation. 3)If retrieval of the standing valve is unsuccessful and it becomes necessary to remove the wellhead, All pressure containing equipment must be tested to the approved permitted pressure and recorded on the daily operations report. If well pressures exceed the SITP/MASP stated in the approved permit, the equipment in use must be tested at a minimum to the new observed pressure. The appropriate District must be immediately notified of this pressure change and a RPM submitted to document the change. 4)Notify the Permitting Section at Least 24 hours in advance of beginning these approved operations AND of any required BOP tests. 5)WAR reports are due no later than noon each Wednesday.
