This is a challenge to the Information Quality (Section 515) of accident data posted on the BSEE website.

Specifically the date of the accident occurrence in many cases is either before the Lease Effective Date or after the Lease Expiration Date. For example, the accident listed with the Date Occurred of May 31, 2013 on Lease Number G22606. The Serial Register Page shows a start date of the Lease as July 1, 2001 and a termination date of July 7, 2010. The accident listed appears to have occurred almost 3 years after the lease was terminated! I have attached the initial part of the webpage and Serial Register Page for ready reference. I have attached an Excel Spreadsheet with 57 cases of date of occurrence being out of the bounds of the Lease Effective and Expiration dates. It appears to be some type of data integrity problem within BSEE database.

I am currently looking for patterns of accidents in the OCS. These data anomalies weaken the utility of my analysis.

I am very willing to work with the BSEE staff in resolving these anomalies.
