Dear Ms. Dlouhy:

This is in response to your Freedom of Information Act (FOIA) request, Number 2013-00049, sent via e-mail on December 7, 2012. You requested various documents regarding the safety of operations on the offshore.

In addition to the responsive reports our office is providing, we are also including a two-page document which provides for a better understanding of the INC-to-Component ratio tool our office uses to promote safe and environmentally responsible oil and gas activities.

Your specific requests and our responses are as follows:

- 1) *The operator safety index (OSI) for years 2010, 2011, and 2012*

The OSI reporting tool as a whole encompasses many different variables and database tables. Due to internal processes and procedure changes since 2010, this report can no longer be run; therefore, no report can be provided to you.

- 2) *The compliance ratio or score for operators and/or facilities for 2010, 2011, and 2012*

Enclosed are nine (9) pages responsive to your request.

- 3) *Any high-risk list of operators or facilities maintained by Lars Herbst or the Gulf of Mexico (GOM) OCS Region to direct and focus inspections*

Neither the Regional Director's office or the GOM OCS Regional offices maintain a high-risk list of operators or facilities. The only high-risk list kept by the GOM OCS Region would be the Increased Oversight list requested in your next item number.

- 4) *A copy of any increased oversight lists that tracks the safety performance of operators*

Enclosed are six (6) pages responsive to your request.

- 5) *A ranking of Black Elk Energy's relative safety performance compared to other operators*

The Black Elk INC-to-Component ratio for the year ending 2012 is "0.0889"; the GOM industry average INC-to-Component ratio for the year ending 2012 is "0.0396". This timeframe was used as the measure since it was the last full year that inspections were completed.

- 6) *The "quarterly meeting summary reports" for 2010, 2011 and 2012*

There are 20 pages responsive to your request which have been withheld under 5 U.S.C., Section 552(b)(5) which protects pre-decisional materials. Exemption 5 is intended to protect the deliberative process privilege, the general purpose of which is to "prevent injury to the quality of agency decisions" by protecting "against premature disclosure of proposed policies before they are finally adopted", and also against "public confusion that might result from disclosure of reasons and rationales that were not in fact ultimately the grounds for an agency's action".

- 7) *The "INCs by operator chart"*

This report is no longer updated and the information is not accurate; therefore, we are withholding this one (1) page report under Exemption 5.

- 8) *Minutes, notes and presentations from the annual performance review and operations meetings conducted in 2010, 2011, and 2012*

There are 3000 pages responsive to your request which have been withheld under 5 U.S.C. Section 552 (b) (7)(e). Exemption 7 is intended to protect records compiled for law enforcement purposes, which if disclosed, could interfere with enforcement proceedings and lessen their effectiveness. In addition, due to the frank nature of the discussions, commercial business information is often discussed; therefore, we are also citing Exemption 4 under 5 U.S.C. Section 552(b)(4). Exemption 4 protects from disclosure of both required and voluntarily submitted information that provides a competitive advantage. It is intended to protect the interests of both the government and submitters of information, and exists to promote open communication between the government and industry, as well as encourage submitters to furnish useful commercial information without fear of loss of fair competition. When submission of information is compelled by the government, this exemption provides the government with assurance that the required submissions will be reliable.

- 9) *All documents and information requested by David Hammer of WWL-TV relating to the "performance dashboard" and/or inspections, safety or rankings of OCS operators*

In response to Mr. Hammer's request, we provided him with the following information:

- ❖ *INC-to-Component Inspected report. This includes both the Platform Operator Statistics and the Platform Parent Operator Statistics*

Enclosed are 23 pages responsive to the request. These two reports were run with the date range of 1/1/09 to 12/31/12 instead of the date range of 1/1/09 to 12/5/12 he requested in his FOIA request.

- ❖ *BSEE's most recent Increased Oversight List*

This report is included in the response for your Item Number 4 above.

- ❖ *Black Elk Energy's current INC-to-Component ratio*
- ❖ *The GOM industry's average INC-to-Component ratio*

These two items is included in the response for item number 5 above.

- ❖ *The names of all GOM operators with worse INC-to-Component ratios than Black Elk and their ratios*

This information is contained in the Platform Parent Operator Statistics report.

- ❖ *The names of all GOM operators who have completed a full SEMS audit to date*
- ❖ *Any correspondence or scheduling information regarding SEMS audits*

To clarify our previous response from April 26, 2013, in regard to the request for the names of all GOM operators who have completed a full SEMS audit to date, the GOM Region received 31 audit reports as of April 11, 2013, but, no audits were completed. A pilot audit meeting was scheduled with one operator but was cancelled by BSEE (the responsive documents were sent to you with our partial response letter). Therefore, a list of operators were not provided. This was the one and only operator contacted. According to the new Workplace Safety Rule (30 CFR 250.1900 (Subpart S) which became effective on November 15, 2010, the operators are required to implement their

Safety and Environmental Management System (SEMS) program by November 15, 2011, and submit their first completed SEMS audit report to the Bureau of Safety and Environmental Enforcement (BSEE) by November 15, 2013.

Sound grounds exist for invoking the above mentioned exemptions. This decision was done in consultation with Mr. Martin Steinmetz, Senior Attorney, Office of the Solicitor, Tulsa Field Office.

If you consider this to be a partial denial of your request, you have the right to appeal this decision. In accordance with 43 CFR §§ 2.57(a)(1) and 2.58(a), you may appeal this partial denial of your request to the FOIA Appeals Officer. Your appeal must be received by the FOIA Appeals Officer no later than 30 workdays from the date of this final response to your request. The address for the FOIA Appeals Officer is as follows:

You must include with your appeal copies of all correspondence between you and the Bureau concerning your FOIA request, including a copy of your original FOIA request and this response letter, along with a brief statement of the reason why you believe this decision to be in error. Failure to include this documentation with your appeal will result in the Department's rejection of your appeal. The appeal should be marked, both on the envelope and the face of the letter, with the legend, "FREEDOM OF INFORMATION APPEAL."

**Narrative document clarifying the INC-to-
Component Ratio tool**

Incidents of Noncompliance (INCs)-to-Components Ratio

BSEE has a number of tools that it uses in managing its enforcement strategy and efficiently using its resources to promote safe and environmentally-responsible oil and gas activities on the Outer Continental Shelf (OCS).

Just as the exploration and development of offshore oil and gas is highly complex and technically advanced, the evaluation of the operations for safe and environmentally-responsible practices and compliance with federal regulations involves many indicators and is not based on one specific tool or measuring system.

One indicator used is the **Incidents of Noncompliance (INCs)-to-Components Inspected ratio**.

This tool is used to evaluate an operator's compliance in its production operations. (INCs for drilling operations are compared for individual rig inspections, not components.)

INCs are violations of federal regulations that are observed by a BSEE inspector and issued to an operator. Each INC has a specific resulting action and requires a corrective action by the operator receiving the INC. There are different severity levels of INCs.

Warning – operations can continue and the violation must be corrected within a reasonable amount of time specified on the INC.

Component Shut-in – one activity or one specific piece of equipment is shut-in until the violation is corrected.

Facility Shut-in – the entire facility (all operations) is shut-in until the violation is corrected.

A **component** represents one piece of equipment or mechanical instrument such as a compressor, separator, well, etc. Therefore, inspection of components can result in varying number of INCs if violations are detected. That is, INCs and components are not one to one relationships.

Incidents of Noncompliance (INCs)-to-Components Ratio

The INC to Component ratio provides a quick review of an operator's compliance history on production platforms through a ratio of the number of INCs issued to the number of components inspected. This tool is used as one measure of an operator's performance.

It is not recommended that an operator's ratio be the sole indicator in evaluating its overall performance. Due to many factors, the ratio cannot be considered statistically valid across operators:

- (1) The severity of the INCs issued is not weighted. One operator with a high ratio may have a total INC count that includes 75% Warning INCs while another operator may have a relatively low ratio but 100% of the INC count includes Facility Shut-in INCs.
- (2) The number of components available for inspection may not be a large enough sample size to generate a statistically valid ratio. An operator with few production platforms and a smaller number of components may have a greater ratio than an operator with a large number of production platforms and more components.
- (3) Operators may also receive INCs for violations that are not directly tied to components. Many of the General or (G) INCs that are issued to operators fit this category. When this occurs, the component is not always the best way to normalize the INC data.

BSEE staff use performance measures such as the INC to Component ratio in conjunction with other information gained through inspections and meetings with company officials as well as other tools to strategically and effectively promote safe and environmentally-responsible oil and gas activities by OCS operators. Although certain computer generated reports may provide an operator ranking for that tool, the Bureau evaluates each operator on an individual basis and does not rank-order operators.
