NATIONAL NOTICE TO LESSEES AND OPERATORS OF FEDERAL OIL, GAS, AND SULPHUR LEASES AND PIPELINE RIGHT-OF-WAY HOLDERS ON THE OUTER CONTINENTAL SHELF

Electronic Submittal System for Pipeline Applications, Plans, Notifications, and Reports

This Notice to Lessees and Operators (NTL) provides information and guidance about the Bureau of Safety and Environmental Enforcement's (BSEE) Technical Information Management System (TIMS Web) Pipeline extension module (ePipelines) integrated with TIMS Web Submittals. The primary goal of the ePipelines module is to integrate business and process-specific data into the existing TIMS Web Submittals application, as-managed by the Gulf of Mexico (GOM) Regional Field Operations, Pipeline Section. Another goal is to provide stakeholders, including pipeline right-of-way (ROW) holders, ROW pipeline identified operators, lessees, and operators – as well as other authorized parties -- with ease of access to BSEE ePipeline forms and methods of submitting data. In addition, the system facilitates communication between BSEE and industry and reduces the creation of paper files.

Background

Pursuant to 30 CFR part 250, Subpart J, BSEE requires pipeline ROW holders, ROW pipeline identified operators, lessees, and operators to submit pipeline installation, modification, decommissioning, ROW grant, and ROW grant assignment applications, as well as corrective action plans, various notifications, and reports for approval, acceptance, and acknowledgment.

Pursuant to 30 CFR 250.909 through 30 CFR 250.918, BSEE requires pipeline ROW holders, ROW pipeline identified operators, lessees, and operators to submit verification plans and certified verification agent (CVA) nominations for pipeline risers that are subject to the Platform Verification Program; and subsequently, the approved CVA(s) are required to submit reports.

30 CFR 250.1007 identifies pipeline installation application requirements. 30 CFR 250.1008 describes required pipeline-related notifications, reports, and plans of corrective action. 30 CFR 250.1751, 250.1752, and 250.1753 identify pipeline decommissioning application and reporting requirements.

Under 30 CFR 250.186(a)(3), you may submit digital data when BSEE is equipped to accept it.

Electronic Pipeline submittals

BSEE has implemented an internet-based system called the TIMS Web (<u>http://timsweb.bsee.gov</u>) that provides a tool for regulated entities or their authorized representatives to exchange information with BSEE electronically. Effective January 27, 2020, the TIMS Web ePipelines component of TIMS Web Submittals provides pipeline ROW holders, ROW pipeline identified operators, lessees, and operators a means to submit and track pipeline application data, pipeline status notifications, required pipeline-related reports, and other pipeline-related submissions and BSEE actions outlined in 30 CFR part 250. The ePipelines system is similar to the electronic well permitting and reporting system referred to as eWell, which BSEE (and its predecessors) have successfully used since 2004.

The use of this electronic system replaces the need to submit pipeline-related requests, notifications, and reports in hard copies as required by:

BSEE will still accept hard copy submittals. However, BSEE recommends that you submit pipeline related submittals electronically in order to improve review and approval efficiency. BSEE believes this electronic submittal system will provide an improved means of presenting, reviewing, and taking actions regarding pipeline-related submissions. This electronic system allows you to track the status of your submittals while increasing the efficiency of BSEE's review and approval processes.

Registration Procedures and Application Manual

• Anyone interested in using the ePipelines system must first register for a TIMS Web account. The process to obtain a TIMS Web account is identical to the process to obtain eWell accounts. - To obtain access to ePipelines, ROW holders, lessees, and operators must submit the appropriate signed User Access Request Form (in original hard copy format) to the Bureau of Ocean Energy Management, Gulf of Mexico Outer Continental Shelf Region, Adjudication Unit (GM231A), 1201 Elmwood Park Boulevard, New Orleans, LA 70123. This must be an original signed form; copies are not accepted.
